Mr. Warner stated that Salisbury University/ESRGC has been drawing down funds consistently since the beginning of the project and the County Economic Development offices have started to draw on their available funds as well. Everyone is confident that all available funds will be utilized by the end of the grant period. Ms. Spicher made a motion to accept the budget report, Ms. D'Arcy seconded the motion. At the most recent GIS Committee meeting, City of Cambridge GIS Specialist Scott Shores shared updates of these projects that were so impressive, Mr. Warner wanted ESRGC Senior GIS Analyst Logan Hall and Mr. Shores to share the projects at this meeting. Mr. Warner introduced Mr. Hall and Mr. Shores.

Mr. Hall provided a fabulous PowerPoint presentation that summarized the last four or five years of the Housing Quality Studies throughout the Mid-Shore region. Mr. Shores demonstrated how the City of Cambridge is now able to compare the progress being made utilizing interactive mapping of the original study compared to this past summer's study.

The men then shared how the GIS Circuit Rider position was able to assist Mr. Shores and the City of Cambridge ADA sidewalk committee with GIS support. They emphasized the speed at which this work was able to be turned around once requested, less than two weeks.
