The Mid-Shore Regional Council held a scheduled quarterly meeting on December 12, 2013 at the Hyatt in Cambridge. Action Items

Chairman Bartlett called the meeting to order at 11:07 a.m., at which time introductions were made. Chairman Bartlett announced he was in possession of Senator Richard Colburn's proxy. Also in Chairman Bartlett's possession were printed copies of the electronic votes by members Gale Nashold, Ricky Travers and Rick Price on the four voting items under Action Items. These signed votes will be placed among the minutes (see attached). Wilbur Levengood was carrying a proxy for Jeff Ghrist.

Approval of September 18, 2013 Minutes

Eastern Shore Entrepreneurship Center (ESEC)

ESEC Executive Director Mike Thielke gave the following updates.

ESEC held another round of Business Plan Competitions which included a \$35,000 adult competition as well as a student competition.

The revolving loan fund portfolio is approximately \$2 million and \$1 million is currently available.

Shore Venture held another year of entrepreneurship training classes that were fully supported by a foundation with refundable tuition for those completing the course.

hotDesks co-working space at the TCCLES building and startup community in Salisbury are both gaining momentum.

Recent funding included \$200,000 from DHCD to RLF portfolio and \$50,000 from local foundation to operating. \$30,000 is anticipated from RMAP USDA to operating.

Maryland Broadband Cooperative

MdBC President and C.E.O. Pat Mitchell proudly stated that Maryland Broadband has a presence in EVERY rural county in Maryland and can provide service in each county. He also stated that construction from Cambridge to Taylor's Island has started in preparation for the bay crossing.
